#### **Terms and Conditions**

- 1. The contract for for minor electrical repair and supply of electrical fittings/accessories work, and C-Dot EPABX exchange will be valid for a period of 24 months w.e.f. award of the contract. However, the contract may be further extended as per the requirement of the Ministry for a period of six months or may be curtailed/terminated before expiry of this period owing to deficiency in service after giving one weeks' notice to the selected firm.
- 2. The 'Technical Bid' should contain company profile, authenticated documents to prove the eligibility of all conditions and any additional documents to show the competency of the firm. The firm/agency should also upload the copy of PAN in the Technical Bid and a copy of the Earnest Money Deposit of Rs. 10,000 (Ten thousand only) in the form of Bank Draft in favour of "Pay and Accounts Officer, Ministry of Steel, New Delhi.
- 3. The repair work is to be carried out in the premises of the Ministry of Steel, Udyog Bhawan, New Delhi.
- 4. The firms are required to upload copies of the following documents along with the Technical Bid (information furnished by the firm for evaluation of technical bids) in .pdf format, failing which their Bids shall be summarily/uprightly rejected and will not be further considered:
  - (a) Scanned copy of Annexure-II (information furnished by the firm for evaluation of technical bids)
  - (b) Scanned copy of Earnest Money Deposit (EMD)
  - (c) Scanned copy of PAN Card
  - (d) Scanned copy of GST registration certificate
  - (e) Scanned copy of work experience certificate
  - (f) Scanned copy Annexure-VI (details of bank account of firm)
  - (g) Scanned copy of cheque from account furnished in Annexure-VII
  - (h) Scanned copy of financial statement of account of firm like Balance Sheet, Profit & Loss Account etc.
- 5. Payment shall be made by electronic transfer to the account of the firm on submission of pre-receipted typed bill in triplicate. No advance payment shall be made in any case. Bidder should furnish details of bank accounts in Annexure-VIII along with the other requisite documents.
- 6. Overwriting or correction in any of the tender document is not permissible. The rates should be quoted both in figures and words.
- 7. Any loss or damage of any item during repair work within the premises of the Ministry of Steel shall be the liability of the contractor and the Ministry of Steel as its discretion deduct total cost of the item or any part thereof from the Bill of the contractor.

- 8. The contractor shall depute at least one licensed electrician to the Ministry every day (9.00 AM to 5.30 PM) for doing day to day electric repair work. If any eventuality arises, Ministry of Steel shall within its competence to requisition the service of electrician on Sunday/Holiday and beyond office hours without payment of any additional remuneration. The contractor shall also keep sufficient stock of spare parts which may be required for repairing/maintenance in the event of the electric items becoming non functional or defective during the currency of the contract.
- 9. The contractor shall be responsible for payment of wages/settlement of dues of workers engaged by the firm as per the prevailing labour/wages laws in force in NCT of Delhi and the Ministry of Steel shall not be the party to any dispute between the contractor and the worker.
- 10. No extra payment/compensation whatsoever on account of natural calamity/accident or otherwise will be made to the firm.
- 11. In case of any deficiency in service, a penalty of 5% of the total amount of the Bill for the relevant period will be imposed.
- 12. The contractor shall use the material conforming ISI standards wherever applicable for supply of electric items.
- 13. The contractor shall undertake repair work only after receiving a written order signed by the SO(GA). Any work undertaken otherwise shall be treated as unauthorized work and the cost of such work shall not be paid by the Ministry.
- 14. The contractor shall maintain job card for each repair work undertaken by him. The card should be got signed by the official concerned after satisfactory completion of work.
- 15. The successful contractor shall be required to do the work during the entire period of one year at the rates as approved on the basis of the quotation. If for any reason, the firm is not able to do the work, the same shall be got done from the open market at the cost of the contractor and the expenditure incurred thereon shall be recovered from the Bill of the contractor.
- 16. The conditional bid will not be accepted under any circumstances.
- 17. The contractors himself make arrangements for fitting of material in electric item and he will quote rates for material items including of all service charges as well as taxes.
- 18. The firm must have valid GST Nos.
- 19. The firm should have a minimum 3 years experience in the operational area. List of three successfully completed/ present contracts from any Ministry/Govt. Departments/Autonomous body/CPSEs may also be enclosed with the quotation.
- 20. In case more than one bidder quoted the same rates resulting in a tie, the lowest bidder will be decided on the basis of highest turnover during the last 3 years.

- 21. The successful tenderer will have to deposit a Security-cum-Performance Guarantee of 5% of contract value in form of Fixed Deposit from any Nationalized Bank drawan in favour of pay and Accounts Officer, Ministry of Steel, New Delhi within 30 days after notification of the award. It should remain valid for a period of 60 days beyond the date of compilation of all contractual objects. The Performance Security deposit will be refunded only ater satisfactory completion of the contract.
- 22. No increase in amount shall be considered during the period of Annual Contract. No other charges like transportation/fare etc., will be payable.
- 23. If the firm commits breach of any of the term and conditions who not able to complete the work in time or the quality of work is not of the desired level etc, the contract will be cancelled and security deposit shall be forfeited.
- 24. This Ministry reserves the right to terminate the contract any times without assigning any reason therefore.
- 25. The firm is not black listed by any Government Ministries/Departments nor any criminal case is registered/pending against the firm or its owner/partner anywhere in India.
- 26. No bidder is allowed to withdraw the tender. In case of withdrawal, the EMD shall stand forfeited besides action being taken to black list the bidder.
- 27. The bidder will indicate the complete address of their firm/office and residence along with telephone numbers and other related information.
- 28. Each and every page of NIT will be signed by the authorized signatory of the Firm/Agency and submitted along with the tender.
- 29. The tender will be finalized on the basis of the net bundled rate and not on the item wise lowest rate quoted by the bidders.
- 30. Only domestically manufactured items to be used.

#### **Arbitration Clause**

31. Arbitration: In the event of any dispute or disagreement under or in relation to this Agreement or over the interpretation of any of the terms hereinabove contained or any claim or liability of the party, the same shall be referred to the sole Arbitrator to be nominated by mutual consent of both parties therein. The intending party will serve notice in writing upon the other party notifying its intention for appointment of Arbitrator. Should both parties fail to agree on by mutual consent, then Ministry will appoint the sole Arbitrator. The provisions of Arbitration and Conciliation Act, 1996 will apply. The arbitration proceedings will be held in New Delhi. The Arbitrator will give reasons for his award and the award passed by the Arbitrator shall be final and binding upon the parties herein. Such reference shall be deemed to be a submission to arbitration under the Indian Arbitration and Conciliation Act, 1996, or of any modifications or re-enactment there of including the rules framed there under.

# Instructions for Submission of e-Tender(in two bids system-Technical Bid and Financial Bid)

As per the directives of Department of Expenditure, Ministry of Finance, this tender document has been published on the Central Public Procurement (CPP) Portal (<a href="www.eprocure.gov.in">www.eprocure.gov.in</a>). The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in submission of e-Tender through the CPP Portal. More useful information for submitting online bids on the CPP portal may be obtained at <a href="www.eprocure.gov.in/eprocure/app">www.eprocure.gov.in/eprocure/app</a>

#### REGISTRATION

- 1. Bidders are required to enroll on the e-Procurement module of the CPP Portal (<a href="https://eprocure.gov.in/eprocure/app">https://eprocure.gov.in/eprocure/app</a>) by clicking on the link "Online Bidder Enrolment". Enrolment on the CPP Portal is free of charge.
- 2. As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3. Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP portal.
- 4. Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (DSC) (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India(e.g. Sify/TCS/nCode/eMudhra etc.) with their profile.

- 3 Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document/schedule and they should be in PDF formats. Bid documents may be scanned with 100 dpi with black and white option.
- 4 To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use "My Space" area while submitting a bid. This will lead to a reduction in the time required for bid submission process.

#### SUBMISSION OF BIDS

- 1. Bidder should log into the site well in advance for bid submission so that he/she upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to any issues.
- 2. The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.


