Background

- Steel Import Monitoring System 2.0 (SIMS 2.0) requires importers to submit advance information in an online portal for import of iron & steel items appearing in Chapter 72 and 73 of ITC (HS), 2017, Schedule – I.
- The information presented in this report is derived from entries in the 'Steel Import
 Monitoring System 2.0' Portal and may not precisely reflect actual import figures.
 To address potential inaccuracies resulting from user input errors, we have
 implemented methods to identify and adjust outliers for reporting purposes. This
 approach aims to enhance the overall accuracy and reliability of the data
 presented.
- Since SIMS involves registrations for future imports, the monthly figures mentioned in the report indicate registrations made in the particular month, not the imports which have happened in that month.
- For reporting purposes, based on ITC codes data has been categorized in 3 broad categories i.e., Semis, Finished Steel and Scrap.
- Figures in MnT refer to imports in Million Tonnes.
